Assessors/ Teachers/ experts can provide their current association with Training Center/ SSC/ School/ College.

Key responsibilities

- Demonstrate skills like Knowledge and understanding, Analytical thinking, Interpersonal skills, Self-awareness, Teamwork, Communication and IT literacy among others
- Assist in preparing the assessment environment and the candidates for assessment.
- Adhere to the guidance and procedural framework laid down by the CBSE when carrying out and reporting on the outcomes of the assessment.
- Maintain confidentiality of information at all times: while engaged in training and standardization, during and post the live assessment sessions.
- Make professional judgments of students' performance on the basis of observed demonstration of skills, application of knowledge & understanding and in line with the required standard of performance.
- Manage the assessment session in such a way to avoid undue advantage/ disadvantage being given to students.
